# TEN LONG YEARS TO CLEAR HIS NAME...

We live in a world of information and data, where our identities exist inside of databases. In many ways, this makes our lives easier. You can transfer money to and from your bank account in an instant, or get that new jacket you ordered today delivered to your front door tomorrow.

On the other hand, because of the new vulnerabilities that are present in the digital age, your identity is at a greater risk of being stolen or mistaken than it has ever been.

Imagine you lost your wallet, then two years later you discover there is a warrant in Detroit in your name. But, you've never been to Detroit.

Fast forward a few more months; you find out that there are more arrests on your record for public intoxication, resisting arrest, marijuana possession, and illegal possession of a handgun.

Impossible right? Wrong. This happened to a man in Indiana back in 2006.

Authorities finally determined that the criminal was using the Social Security number of the man from Indiana who had lost his wallet. What's worse? This criminal was eventually arrested for murder!



Despite the Indiana man eventually receiving paperwork and documentation clearing his name, his troubles were not over yet.

It turns out, though the Government admitted to the mix-up, the records were never actually corrected. This oversight resulted in the revocation and suspension of his driver's license and the denial of a handgun permit.

This also caused him to struggle to find gainful employment, forcing him to take lower paying, temporary assignments. It took nearly a decade before he was able to gather enough documentation to convince employers that the criminal record was not truly his.

The real tragedy here is that these types of scenarios do occur. **They can happen anytime, anywhere, and to anyone.**

# THE CASE OF THE CAROUSEL BANDIT...

A gun belonging to someone who trains police officers is now on the streets after it was stolen from the unlikeliest of places—a baggage carousel at San Francisco International Airport.

This is how it happened: the gun owner legally checked it with TSA at McCarran International Airport in Las Vegas before boarding his flight.

However, something went wrong and the gun somehow arrived at SFO way before the owner did.

When it arrived, “It was put on a carousel for hours until somebody just took it. Literally just walked out with it,” the owner said.

In a statement, the airline said, “We have filed a police report and are working with local authorities to investigate the customer’s missing item. The item was unloaded onto the correct baggage carousel and we are using surveillance videos to investigate what happened.”

While that’s all well and good, the original owner still worries about the stolen firearm.


“Somebody could get hurt because my gun is out there. This could fall on me. On my conscience.”

# THE DIRE CONSEQUENCES OF A STOLEN GUN

In Pensacola, Florida, a group of teenagers breaking into cars at an apartment complex stole a Ruger handgun from a Ford Fusion, then played a video game to determine who got to keep it. One month later, the winner, an 18-year-old with an outstanding warrant for his arrest, fatally shot a 75-year-old woman in the back of the head. She had been paying the criminal teen to do odd jobs around the house. He shot the woman after she accused him of stealing her credit cards.

In Gilbert, Arizona, a couple returned home to find their back door pried open and all 6 of their firearms missing. Police recovered one of the shotguns eight months later on the floor of a getaway car that was occupied by three robbers. The robbers held up a gas station and led officers on a car chase in the nearby city of Chandler.

In Atlanta, a thief broke in through a front window of a house and stole a firearm. The following year, a convicted felon used the weapon to fire on a car as it was leaving a gas station, sending two men to the hospital. Two months later, the same felon used the rifle to fatally shoot his girlfriend's 29-year-old neighbor.
